President's Report - Dr. Marsha Krotseng

- Dr. Krotseng thanked those who made the presentations to the legislators possible.
- Discussed the Strategic Plan and the Goals to focus on the students.
- Access
 - Sent out message earlier this week informing the campus and the Board that G-MAC did
 not invite BSC to proceed with application but offered no explanation. A consultant will
 be coming to campus to review the Athletic Program and provide recommendations.
 - o International Student Reception held earlier this month.
 - Conference for area Girl Scout Leaders who want to continue to partner with Bluefield State.

 - Home Depot on September 27 had 350 to 400 volunteers working across campus.
 - October 23 Mr. John Ellison will be performing at BSC and speaking on how to make dreams happen. He wrote and recorded the song "Some Kind of Wonderful." The performances will be at 10:30 a.m. and 7:00 p.m. with a reception to follow the evening performance.

Financial Report and Update - Ms. Shelia Johnson

Ms. Johnson called attention to the Financial Report contained in the Board packet and reviewed the information. The new state system called OASIS will begin July 1, 2014 bringing a lot of changes to the

state processes. Ms. Johnson also updated the Board on the progress of the construction across campus. Discussion followed.

Enrollment Update - Dr. David Gnage

Dr. Gnage reviewed the enrollment report and compared this year's enrollment numbers to the previous years' enrollment. Mr. Bezjak requested a trend analysis for the various programs. Discussion followed.

Informational Technology - Mr. Tom Cook

- Mr. Cook talked about the BSC Portal and the ability of students to have a single sign-on for all functions.
- Contacting students to enroll for spring semester.

- Requests have been received for Deans to have access to list serve for various categories so students may be contacted with specific information.
- Working with a consultant for the online programs to find better ways to serve students efficiently.
- BSC Mobile App usage has increased by 46%.
- There have been over 800 admissions applications submitted online. With the new process, students are able to apply and check on the status of their application online. Online payments are also available for student convenience.
